Subject: Tentative seniority list of Head Assistants of Revenue Department (Divisional Cadre) Jammu Division – Objection of Sh. Ghulam Nabi, Head Asstt.

Whereas, vide this office Notification No. DIVCOMJMU(ESTT) 58 of 2016 dated 31.10.2016, a tentative seniority list of Head Assistants as it stood on 31.10.2016 was issued and circulated among all the concerned Head Assistants through Deputy Commissioners of Jammu Division and print media for filling the objections, if any with regard to their placement in the said tentative seniority list by or before 30.11.2016; and

Whereas, Sh. Ghulam Nabi, Head Asstt. filed objection which was received through Deputy Commissioner Reasi vide letter No. DC/Rsi/SO/2016-17/161 dated 30.11.2016 on the grounds that Sh. Manmohan Singh & Sh. Ghulam Nabi were placed at S.No. 8 & 9 respectively in the seniority list of Sr. Assistants, whereas, the promotion order of Sh. Manmohan Singh for the post of Head Asstt. was issued on 16.03.2013, and the promotion order of Sh. Ghulam Nabi was not issued with the reason that his APRs were written by the then I/C DC Poonch as at that time of promotion, Sh. Ajeet Kumar Sahu, the then Deputy Commissioner, Poonch was on training out of the J&K State.

Whereas, he has also stated in the objection that his colleague namely Sh. Parveen Kumar, (now Head Asstt.) was existing at S. No. 23 of the final seniority list of Sr. Asstts. whereas, his name was existing at S. No. 9, but the former was further promoted as I/C Section officer, whereas, he was not eligible for the post of Head Asstt. as per version of SRO-74 dated 31.03.2009; and

Whereas, the records were examined, Sh. Ghulam Nabi is existing at S. No. 07 and he has not passed Secretariat Assistant Training Course examination.

Therefore, on the above grounds the objection raised by Sh. Ghulam Nabi is found invalid and is not considered. As such he is placed at his appropriate place as per his seniority.


