Whereas, Shri Rajinder Kumar, in his objection has claimed that Sh. Ram Krishan, Smt. Sudarshan Devi Sharma, Dhian Singh and Smt. Raj Kumari Khajuria are junior to him as they have entered in the Govt; Service as Jr. Asstt. later than him although promoted as Sr.Asstt. on the same date; and

Whereas, the objection was considered and it was found that as per the promotion order issued by Deputy Commissioner, Kathua vide No. DCK/Adm/2010-11/1573-44 dated 27.09.2010. Shri Ram Krishan (SC), serial No. 29 and Smt. Sudersha Devi (RBA), serial No. 30 are senior to him and Smt. Raj Kumari serial No. 32 and Shri Dhian Singh serial No. 31 are junior to him; and

Whereas, it was also found that Shri Dhian Singh serial No. 31 is junior to Smt. Raj Kumari serial No. 32; and

Whereas, Smt. Gulshan Ara Sr. Asstt. SDM office Bhaderwah has represented that in the tentative seniority list her name figure at S. No. 16 while as other Senior Assistants who are junior to her in appointment/qualification/promotion / figures over her; and

Whereas, the objection was examined and it was found that as per the promotion order issued by Deputy Commissioner, Doda vide No.209-18/Acctt/08 dated 14.07.2008 and as per the date of their entry as J.A in the Deptt., Smt. Gulshan Ara is senior to Lal Chand (Sr. Asstt) & Asha Kumar Kotwal (Sr. Asstt.); and therefore she has to be placed higher than these officials; and

Whereas, Sh. Tej Singh Khanyal, serial No. 25 has claimed that Sh. Charan Singh serial No. 24 is junior to him as per promotion order issued by Deputy Commissioner, Reasi vide No. DC/Rsi/SM/1666-70 dated 18.02.2010; and

Whereas, the Deputy Commissioner, Reasi vide his No. DC/Rsi/SA/771 dated 17.01.2012 has recommended that Shri Tej Singh Khanyal Sr. Asstt. be placed at S. No. 24 in place of Sh. Charan Singh Sr. Asstt. being senior to Shri Charan Singh; and

Whereas, Deputy Commissioner, Reasi has further submitted R.B.A certificate of Tej Singh vide No. DC/Rsi/N/391 dated 23.06.2012; and

Whereas, Sh. Mushtaq Ahmed (Sr. Asstt) furnished the R.B.A certificates through Deputy Commissioner, Kishtwar vide No. 2798/SQ/12 dated 31.01.2012 and requested for including his name under R.B.A category; and


Whereas, name of the official has been included under RBA category; and


