The appointees shall be on probation initially for a period of two years.
7. The Deputy Commissioner Jammu / SDM concerned shall take precaution to ascertain genuineness of the qualification certificates/ documents and shall verify

And if on verification of the certificates produced by the appointee are proved fake and forged, the appointment shall be cancelled ab initio.

8. The DDOs shall release the salary in favour of the appointees only after receipt of character and antecedents verification report from IGP (CID).
9. The interim arrangement, if any, made against the above posts(s) on deputation or temporary basis shall be deemed to have been terminated / seized forthwith and the incumbent if in service be reverted to his original cadre.
10. The appointment of the candidate is subject to the outcome of writ petition, if any, pending in any court of law on the subject.
11. The appointees are deemed to have been relieved from this office and shall join new place of posting without availing joining time.
