NOTICE

Whereas, one Shri Shakti Kumar, Girdawar working in Divisional Commissioner office represented for retrospective effect from 24.12.2012 instead of 19.12.2013 on the grounds that some of his counter-parts / batch mates appointed with him as Patwaries and juniors have been granted the benefit of promotion as Girdawars w.e.f. 24.12.2012; and

Whereas, perusal of the record reveals that at the time of DLDPC meeting held on 25.02.2013, the promotion of Shri Shakti Kumar, Patwari (who was figuring at S. No. 241 in the seniority list of Patwaries) to the post of Girdawar was deferred due to non-availability of APRs and Vigilance Clearance, whereas, the following Patwaries who are juniors to him were promoted w.e.f. 24.12.2012: and

Whereas, subsequently in the DLDPC, meeting held on 30.01.2015, the promotion of Shri Shakti Kumar, Patwari was approved w.e.f. 19.12.2013 subject to availability of APRs and Vigilance Clearance and on the receipt of vigilance clearance and APRs, the said Patwari has been confirmed / promoted as Girdawar vide this office order No. DIVCOMJMU(ESTT) 63 of 2016 dated 03.12.2016 notionally w.e.f. 19.12.2013.

Therefore, keeping in view the above facts and figures, the case of the Sh. Shakti Kumar, Girdawar is considered for retrospective effect from 24.12.2012 notionally instead of 19.12.2013 and placed him at S. No. 337-A after the name of Sh. Jaswant Singh and before the name of Sh. Mohd. Sharief in the final


