Subject: Circulation of re-framed seniority list of Patwaries as it stood on 30.06.2008 and final seniority the Girdawars as it stood on 01.01.2019 of Revenue Department, Jammu Division.

CORRIGENDUM

Whereas, in light of judgment dated 17.08.2017 passed by the Hon'ble High Court in SWP No. 1221/2013 MP Nos. 1/2017 & 1772/2013 titled Sh. Mohan Lal V/s State of J&K and Ors, a seniority list of Patwaries issued vide No. 102/182/Ptw/Seniority/2009 dated 12.12.2009 has been re-framed vide No. DIVCOMJMU(ESTT) 11 of 2018 dated 07.05.2018 as per merit list issued by SSB since 1998 and accordingly a seniority list of Girdawars as it stood on 01.01.2019 has been issued on the same basis; and

Whereas, the Financial Commissioner (Rev), J&K vide letter No. FCR(A)41/JammuDivn/2019 dated 09.04.2019 has forwarded a representation dated 14.02.2019 of batch 1999 (erstwhile District Doda) for take appropriate necessary action regarding re-fixation of their seniority as Patwaries & Girdawars, above the batch of District Rajouri as per merit lists of selection of Patwaries issued by SSB; and

Whereas, the matter has been taken up with the Administrative Department Revenue vide letter No. 102/96/Snty/GQ/III/10-11 dated 29.04.2019 for obtaining of selection lists of District Rajouri / Doda from J&KSSB; and

Whereas, J&K SSB vide letter No. SSB/Sel/Secy/15-16/99/J/2910-11 dated 10.05.2019 has provided the selection lists of both the batches of 1999 (district Rajouri & erstwhile Doda) and perusal of the said selection lists reveals that the list of District Rajouri was issued on 18.06.1999 and erstwhile District Doda on 23.03.1999; and

Whereas, the case has been examined and it has been found that the Patwaries of erstwhile District Doda (batch 1999) selected on 23.03.1999 are senior to Patwaries of District Rajouri (batch 1999) selected on 18.06.1999.

Therefore, in view of the above facts necessary corrections needs to be incorporated in the seniority list of Patwaries and Girdawars already issued by this office which is as under:
