

As per the bonovo enquiry dated 07-10-2016 conducted by the
Tehsildar concerned, states that as per mutation No. 165 (Revision)
dated 30-01-1981 bearing Khata No. 21, 24 and 25 total measuring
48 Kanals-01 Mahals instead of land measuring 38 Kanals-03 Mahals
falling under Khata No. 20, 22, 23 needs to be corrected. Therefore,
Mutation No. 165 dated 30-04-1981 has been executed in favour of S.
Prab Singh S/o Ravat Singh measuring 48 Kanals bearing Khata No.
21, 24 and 25 and the same has been corrected as per spot. S. Prabh
