Whereas, one Sh. Subash Chander, the then Patwari of District cadre Udhampur was approved for promotion to the post of Girdawar by the DLDP meeting held on 30.01.2015, but the promotion order was not issued at that time due to non production of Vigilance Clearance and APRs. However, he is placed as I/C Girdawar vide this office order No. DIVCOMJMU(ESTT) 08 of 2015 dated 14.02.2015; and

Whereas, after the receipt of Vigilance Clearance/ APRs and other required documents, this office vide order No. DIVCOMJMU (ESTT) 21 of 2022 dated 25.08.2022, has issued confirmation/promotion order of Sh. Subash Chander to the post of Girdawar, but his name was not incorporated in the seniority list of Girdawars; and

Whereas, Financial Commissioner (Rev), J&K vide letter No. FCR-GAZ/45/2024-06(7526528) dated 31.07.2024 has forwarded the representation of Sh. Subash Chander, Girdawar, in which he has requested to incorporate his name in the seniority list of Girdawars as it stood on 01.01.2019.

Therefore, after examine the records and as per Rule 24 of Classification Control & Appeal Rules, 1956, Sh. Subash Chander, Girdawar is hereby placed at S. No. 453-A below the name of Mohan Lal S/o Birbul (figuring at S. No. 453) and above the name of Mohd. Ashraf S/o Gh. Mohd. Sheikh (figuring at S. No. 454) in the seniority list of Girdawars issued vide notification No. vide No. DIVCOMJMU (ESTT) 05 of 2019 dated 05.02.2019 as it stood on 01.01.2019.
