Revision against mutation of Warasat No. 1435 dated 06-05-2013 by virtue of which petitioner has been excluded from the Warast and respondents No. 1 and 2 has been illegally included in Warasat of Mohd. Din in respect of land falling under Khasra No. 667 measuring 18 Kanal 7 Marlas situated in village Fatehpur (Gurian) Tehsil and District Rajouri for setting aside the same and also for correction of Girdawari entries and giving effect to Will executed in favour of petitioner by her fater in law in respect of 4 Kanals of Land from Khasra No. 667 local description / identification whereof is "Chakla Dulla" along with a kacha house and in the meanwhile perpetually restarting respondent No. 1, 2, 4 to 11 from raising any construction in aforesaid land or alienating the same ad causing any interference into possession of the petitioner over the aforesaid land.

ORDER

The case came up for hearing. Nobody appeared for petitioner. Respondent No.6 alongwith counsel present. He informed the court that the issue which was a family dispute has now been resolved amicably between the parties and that petitioner is not interested to contest the case. He produced an affidavit executed by petitioner in this regard. And the same is placed on file.

In view of the above, this court is of the opinion that when the parties have resolved their dispute & petitioner do not want to contest the case, no further proceedings are required in the matter.

Hence the revision petition at hand is dismissed as withdrawn.

Stay issued, if any, shall stand vacated. The case file be consigned to records after due completion.
