Sub: Minutes of the Meeting regarding implementation of mitigation measures for the control of 3rd wave of Covid-19 pandemic in Jammu Division held under the Chairmanship of Divisional Commissioner, Jammu at 5.00 PM on 15-1-2022

A meeting regarding implementation of mitigation measures for the control of 3rd wave of Covid-19 pandemic was held under the Chairmanship of Dr. Raghav Langer, IAS Divisional Commissioner, Jammu at 5.00 PM on 15-01-2022.

Divisional Commissioner, Jammu, highlighting the evolving situation of Covid-19 stressed upon the application of fundamental principles of Patient Care, management of asymptomatic Covid Patients in Home Isolation and symptomatic cases in hospitals and mindful referral of patients to the Tertiary Care Hospitals. The following officers participated in the meeting in person;

All Deputy Commissioner's, MD-NHM J&K, Principal GMC Kathua/ Doda/ Rajouri, All CMO's & Medical Superintendent of District Hospitals of Jammu Division, attended the meeting through V.C.

The Divisional Commissioner welcoming all the participants emphasized for adherence to the timelines for effective Preparedness and coordination in light of the evolving situation. He further reiterated that "zero" Covid deaths should be the guiding principle and could be achieved only by early detection and timely hospitalization if required for the patients.

The Divisional Commissioner Jammu discussed that in the weekly Covid review meetings it has been pointed out that the Recovery rate of Jammu Division is lower than that of Kashmir Division, therefore, the Principal GMC Jammu and Director Health Services Jammu may kindly analyze the reason for the difference, so that optimal steps can be taken .Further, Line Listing and Discharge policy for the patients be looked into /analyzed so that an holistic approach can be adopted. Decisions taken in the meeting are detailed hereunder:

The chair directed for reaching out all these unvaccinated people and convincing them to go for vaccination. 6	Availability of designated COVID beds in Level I / II /III Covid Facilities and Bed Occupancy Rate.	The Chair directed that a Proforma stand circulated and reporting should be done on it so that uniform information is circulated in all concerned offices. 	Establishing Online Consultations	MD NHM, J&K informed that currently 1 hub is operating at GMC Jammu and 10 spokes/MHHPs are given the task to teleconsult people (e-Sanjeevani). The MD, NHM requested CMO's to identify such Medical officers who volunteer themselves to participate in tele-consultation to convert it into 24X7 facility The Chair directed the concerned that daily report in this regard should be shared with this office. The GMC's linked to concerned districts should take a lead in this regard. For other districts, Deputy Commissioner concerned shall notify the Triage Centres in consultation with all stakeholders. 17	Activation of Dedicated Covid Hospitals and Covid Care Facilities	The chair directed for activation of dedicated Covid Hospitals and Covid Care facilities in a graded manner, based on the analysis of the evolving situation and Hospital/ Institutional bed occupancy status. It was directed that for GMC-Jammu/ Doda/ Rajouri/ Kathua and Associated Hospitals; the Principal GMC's shall designate dedicated Covid Hospitals/ facilities in order of priority; as the situation evolves. Similarly, in case of all other peripheral hospitals; such designation shall be done by the concerned DCs in due consultation with Director Health Services, Jammu/ CMO concerned. The Deputy Commissioners were also directed to activate their Level-III Covid Care Facilities & Panchayat CCC's based on need assessment, under an intimation to this office. 18	OPD/ Elective Surgeries	It was directed by the Chair that any decision regarding full/ partial suspension of OPD services/ Elective Surgeries shall be taken by the concerned in due course of time, after full assessment of the evolving situation. In respect of Government Medical Colleges and Associated Hospitals; the concerned Principal GMC shall take the decision in the best interest of patient care; and for the peripheral institutions, the said decision shall be taken by the Deputy Commissioner concerned in consultation with Director Health Services, Jammu/ Concerned CMO. Deputy Commissioner's and CMO's were directed to analyze the functioning of low performing medical blocks with regard to testing, vaccinations, high positivity, etc and look into the shortcomings so that effective Covid Management can be ensured.

The Chair directed the Principal GMC, Jammu/Director Health Services to look into the deployment of manpower in Covid Hospitals in the shape of final year students of GMC, Nursing Schools and Colleges, for ensuring manpower at all levels to meet the requirement in handling the human resource requirement of the Covid Hospitals etc.

The MD, NHM informed the Chair that attractive remuneration for Covid-19 duties shall be provided to these final year students. The Chair directed MD, NHM to also work out the modalities of services of trained ITI students/ graduates especially in the operationalisation of OGP's & Manifold systems in the Hospitals. Divisional Commissioner, Jammu also asked MD, NHM to look into the allotment of 4x4 Ambulances in the hilly Districts of Jammu Division.

Principal GMC's, Dir Health services, DC's / SSP's were told to give Daily Press Briefings so that the masses are kept abreast with the daily Perspective and rumors are not fueled at Division and District Level. Further the Chair directed for affixation of information with regard to Institutional/ Paid Isolation facilities at Airports, Railway stations, Bus stands for travelers to the UT for their facilitation; in case isolation is required.

Principal GMC Jammu and Director Health Services Jammu were requested for activation of IIIM Labs, Jammu and RTPCR lab at Udhampur to its full capacity along with circulation of Resident Doctors at peripheral GMC's /District Hospitals to fulfill the manpower requirement and trainings in the district.

All DC's were directed to provide the details of availability of funds under Panchayat CCC, expenditure done and balance requirement to clear the liability of JKMSCL. The DCs were also directed to protect the requirement of funds under SDRF Covid up to 31-03-2022 and the present availability of funds under SDRF in the Districts.

The meeting ended with a vote of thanks to all participants.
